BACKGROUND:

S.E.E.D.S understands that your privacy is important to you and that you care about how your personal data is used. We respect and value the privacy of everyone who visits this website, www.seeds-exercise-dance.com "Our Site" and will only collect and use personal data in ways that are described here, and in a way that is consistent with our obligations and your rights under the law

1. Definitions and Interpretation

2. Information About Us

7. How Do You Use My Personal Data?

Under the GDPR, we must always have a lawful basis for using personal data. 11. How Can I Control My Personal Data?

- 11.1. In addition to your rights under the GDPR, set out in Part 5, when you submit personal data via this site, you may be given options to restrict our use of your personal data. Normally, we aim to provide a complete response, including a copy of your personal data within that time. In some cases, however, particularly if your request is more complex, more time may be required up to a maximum of three months from the date we receive your request. You will be kept fully informed of our progress.

14. How Do You Use Cookies?
